Procedures for Obtaining a Short-Term Residency Business License

A Town of Bath Short-Term Residency Business License will need to be obtained by every business or individual operating a B&B, Airbnb, or other Short-Term Rental in the Town of Bath. This application can be downloaded from townofbath.org, picked up in person at the Police Department or Town Hall, or received via email or fax by calling 304-258-1198.

Town of Bath Ordinance 2024-03-08: Bed and Breakfast, Airbnb, and Other Short-Term Rentals

The purpose of the regulations set forth in this ordinance is to provide a procedure to allow the rental of private residences to visitors on a short-term basis, while ensuring that such rental use does not create adverse impacts to residential neighborhoods due to excessive traffic, noise, and density. Additionally, this section is intended to ensure that the number of occupants within such rental units does not exceed the design capacity of the structure to cause health and safety concerns, and that minimum health and safety standards are maintained in such units to protect visitors from unsafe or unsanitary conditions.

You must present a copy of your West Virginia Business Registration Certificate with the Business License application. The Business Registration Certificate can be obtained by contacting the West Virginia Department of Tax & Revenue 1-800-982-8297 or by visiting their website www.business4wv.com.

An individual Bed and Breakfast, Airbnb, and Other Short-Term Rentals License is required for each rental unit.

The Business License application, Short-Term Rental Information Pages and \$200.00 fee/receipt of payment can be presented in person, emailed to adminbspd@morgancountywv.gov or sent by mail with all supporting documentation and payment to the address below:
